## **Gerald Augusto Campership 2026**

This fund was set up at the Chautauqua Region Community Foundation (CRCF) in memory of Gerald Augusto. It is designated to grant one or more camperships to elementary or middle school aged children who are interested in attending single day or week-long Audubon Day Camps. Donations made to camperships throughout the year are awarded to campers to reduce or eliminate camp registration fees. At the end of the year, any remaining funds are reinvested to support even more campers the next year.

### **Who is eligible?**

This campership is available to children aged 5 – 14 years, who experience barriers preventing them access to a quality, nature-based camp experience. Barriers may include, but are not limited to, financial resources, a lack of transportation, work/childcare conflicts, language, or a combination.

### **What is involved?**

Fill out the application below. ACNC will award camperships based on need (number and type of barriers indicated), and may offer partial or full scholarships. Camperships are only awarded in the form of tuition to ACNC Day Camps and have no monetary value outside the organization.
